Sir,

I am directed to refer to this Ministry's order No. R-12011/60/2015-EP (IM-1) dated 09.11.2016 related to admission matter for the year 2016-17 intimating to develop the requisite infrastructure for 2nd professional for consideration of the case for the 2017-18 sessions.

2. The CCIM had carried out an inspection of the institution on 19-20.04.2017 to assess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to this Ministry. On examining the same, it is found that the college is having certain shortcomings for which, an opportunity of hearing was granted on 23.08.2017 to present the case.

3. The recommendations and visitation report of the CCIM, observation of hearing committee based on submission made by the college during hearing have been carefully examined in terms of the “Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC), Ministry of AYUSH for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letter No.R.11011/03/2017-EP (IM-1) dated 12.06.2017 and it has been decided by the central government to grant conditional permission to **Institute of Ayush Medical Sciences, Vimalarjun Nagar, Bhagoo Kheda, Mohanlal Ganj, Lucknow, Pin-261005, Uttar Pradesh** with **100 seats in BAMS (UG) course for the academic session 2017-18** under Section 13C/13A of the IMCC ACT, 1970 subject to the condition that the college shall fulfill the following requirements by 31st December, 2017 which will be verified for granting permission from the academic session 2018-19:

- i. all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016 by 31st December 2017.
 - ii. all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - iii. all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled in toto.
5. The fulfillment of the conditions attached to the permission given above may be made within the specified time period and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify by means of an inspection that the conditions have been fulfilled and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the session 2018-19.
